Out of the three sub counties visited, only Mutunda Sub county had letters from CAO communicating the release of DDEG funds although the letters do not adhere to the dates when funds were released. for instance, the CAOI wrote a letter dated 1st October 2020 for the release of DDEG funds worth 74,731,290 and the district acknowledge funds on 9/2/2021, yet these funds were. The challenge though was noted as errors in dating from CAO's office.

Q2 FY2020/21. Vide CR/210. Dated 16 December 2020. Participants were drawn from the subcounties of Mutunda, Masindi Port, Kigumba, Mboira and Kiryandongo to empower the LLGs address challenges they face filing the sub county quarterly PBS reports.

Q3 FY2020/21, Vide CR/210, Dated 31 March 2021 with participants drawn from the Sub Counties of Mutunda, Masindi Port, Mboira, Kiryandongo, Kyankende and Kigumba. Areas of mentoring included training on how to establish rapport and confidence building, cultivating a culture of self-reliance, building functional partnerships, and participation in development initiatives.
